➤ Academic Scholarship (1)

Commencing Year 7

This Scholarship will be awarded to a Year 6 student who has shown outstanding potential regarding academic performance. The family of the successful applicant will be expected to partially contribute to the School Fees (50%).

➤ Academic Scholarship (1)

Commencing Year 10

This Scholarship will be awarded to a Year 9 student who has shown outstanding potential regarding academic performance. This Scholarship will attract full fee remission. The family of the successful applicant will be expected to collaborate with the School to help maintain high academic standards.

➤ The Allan Griffiths Leadership Scholarship (1)

Commencing Year 10

This Scholarship will recognise a student who has revealed the necessary qualities to become a positive role-model in our community. The potential for the applicant to further develop their underlying leadership skills and qualities will be highly sought after in the selection process. This Scholarship attracts 50% fee remission.

➤ Indigenous Scholarships (2)

Commencing Year 6 – 11

These Scholarships will attract Indigenous Students who have a strong desire to participate in a faith-based Independent School. There will be greater academic and co-curricular opportunities than they may potentially receive otherwise. The School welcomes enthusiastic applicants who meet the following criteria:

- *Not receiving any other scholarship*
- *Enthusiastic about attending school*
- *Likely to successfully complete Year 12*
- *In financial need*

Indigenous Scholarships (2)

The School Council has endorsed with enthusiasm the formation of an Indigenous Scholarship program for students currently in Year 6 – 11, that will enable students to enrol at the School and experience the full range of opportunities that an SJAS education can provide.

The Scholarships will provide the following support:

- 100% of the tuition costs and
- The cost of any compulsory School Camps

All other costs must be met by the successful candidate's parents/guardians.



CONDITIONS OF AWARDS

- These Scholarships are awarded at the discretion of the Principal by recommendation from the Scholarship Committee. Successful candidates must demonstrate a sound academic record together with the potential to make a positive contribution to the School.
- The Scholarships are awarded on the condition that the recipient will finish their secondary education at SJAS. Should a Scholarship recipient leave the School prior to graduation they may be required to return the financial award of the Scholarship to the School.
- The continuation of the Scholarship throughout the year is subject to the recipient making good academic progress, displaying conduct of the highest standard and contributing to the life of the School through participation in leadership and other co-curricular activities.
- The school reserves the right to not award Scholarships if there are no suitable applicants, as determined by the Scholarship Committee.

APPLICATION PROCESS

Academic, The Allan Griffiths Leadership and Indigenous Scholarships

The attached application form should be completed and returned to the School together with:

- A copy of the student's latest school report
- A copy of the student's latest NAPLAN results
- A recent character reference from an adult who knows the applicant well but is not their current education provider or related to the applicant
- A copy of the household's most recent tax return(s), or other documentation. *Applicant for these Scholarships may choose to bring in the appropriate records if called for interview (see below)*
- Proof of Aboriginality (Indigenous Scholarship)

Interviews

Shortlisted applicants will be contacted to attend an interview with the Principal. Parents will have the opportunity to tour the School facilities and meet with Senior School staff and student leaders during the student interview.
